

## Quarry Hill Farm Rental Agreement

CHECK-IN TIME is AFTER 3 P.M. Pacific Time AND CHECKOUT is 11 A.M. Pacific Time. NO Early Check-in or late checkout.

This is a NON SMOKING unit.

### PETS -

PETS are permitted in rental units only with prior approval. \$50 per pet fee applies. Pet owners are responsible for cleaning up any/all pet refuse. Pets are not allowed on furniture at any time. Any evidence of pets on furniture may incur extra cleaning fees. All pets must be up-to-date on rabies vaccinations and all other vaccinations. Heartworm prevention is highly recommended. All pets are to be treated with Advantage or similar topical flea and tick repellent three (3) days prior to arrival. All items above are the sole responsibility of the pet owner. The property owners assume no responsibility for illness or injury that humans or pets may incur while on the premises.

**DAMAGE/SECURITY DEPOSIT** - A \$300 refundable security deposit is required for all reservations. The deposit is fully refundable within (14) days of departure, provided the following provisions are met.

- No damage is done to unit or its contents, beyond normal wear and tear.
- No charges are incurred due to contraband, pets or collection of rents or services rendered during the stay.
- All debris, rubbish, discards and recycling are to be placed in appropriate dumpster and soiled dishes washed. All keys are left on the kitchen table and unit is left locked.
- All keys are to be left on kitchen table at the time of departure.
- No linens are lost or damaged.
- NO early check-in or late checkout.

### CANCELLATION AND REFUND POLICY:

#### Reservation Payment

- A first nights deposit is required at the time of booking for all reservations.
- Reservations are subject to applicable deposits.
- Balance is required 30 days prior to reservation date.
- Pay by Visa, MasterCard, check, cashiers check, or money order

#### Cancellation Policy

- 30 days from reservation date:
  - No refunds unless it is re-rented. \$50 cancellation fee.
- 31-60 days from reservation date:
  - First Nights deposit retained. \$50 cancellation fee.
- 61+ days: \$50 cancellation fee.

**CLEANING FEE** – A \$100 cleaning fee is required.

**MINIMUM STAY** – This property requires a two (2) night minimum stay. Longer minimum stays may be required during holiday periods.

INCLUSIVE FEES – Rates include a one-time linen & towel setup.

NO DAILY HOUSEKEEPING SERVICE – While linens and bath towels are included in the unit, daily maid service is not included in the rental rate, however, it can be arranged at an additional rate.

RATE CHANGES – Rates subject to change without notice.

WATER AND SEPTIC – These properties are on wells and septic systems. The septic system is very effective; however, it will clog up if improper material is flushed. DO NOT FLUSH anything other than toilet paper. No feminine products should be flushed at anytime. If it is found that feminine products have been flushed and clog the septic system, you could be charged damages of up to two hundred dollars (\$200).
